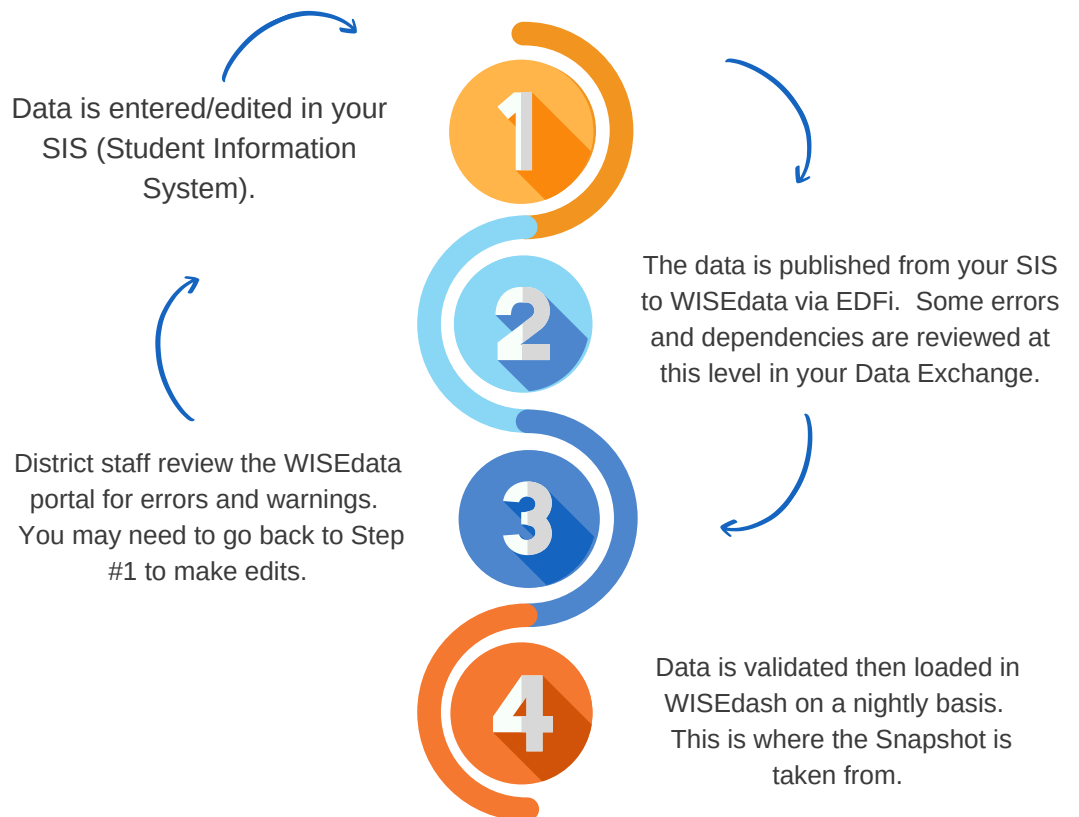

SPRING DEMOGRAPHIC SNAPSHOT

Below is a flow chart that shows the pathway that your data takes to get to DPI and the WISEdata portal. We hope that this diagram is helpful in explaining the lifecycle of data, not only its beginning and end but what happens along the way.



Below are suggestions that we hope will assist you in resolving common error codes related to data collected for the Spring Demographic Snapshot. If these resolutions do not resolve your specific issue, we encourage you to submit a Help Ticket through the PowerSchool Community Case Portal.

ERROR CODE	TITLE	RESOLUTION
7152	Warning - American Indian-Alaskan Native Student submitted with no tribal affiliation.	Can only be edited if district has enabled the Ancestry/Ethnic Origins and Tribal Affiliations data elements. District can acknowledge the warning in the WISEdata portal.
7108	Warning - No English Language Proficiency Code (ELP Code) has been provided.	If you are aware of the student's ELP code for the current school year, submit that code on the WISEdata Student Info page. The ELP Code should equal the number to the left of the decimal in the prior year Overall Composite Proficiency Level
6815	Student Demographics missing for an enrollment.	This error appears if a school submitting an enrollment for a student doesn't also submit that student's demographic information. Review Enrollments & Demographics to ensure that this information has been published for the student. Republish data.
6815	The School Food Service program association has not been submitted by the school	This error appears if you haven't submitted a Food Service record for a student. Enter this information on the student's Lunch page. Unless the student has moved buildings or has a new enrollment record the Food Service record will carry over from year-to-year.
